### Spenddown Plan updates:

Student focus group/information session scheduled

Is hoping to have it take place in the BSC common area, as that's where students congregate

This would be with the goal to have a student funded center, with it being somewhere between 20 and 30 dollars in quarterly fees for a few years.

Has been working with someone with a lot of experience

Last time SGOC did this, around 750 students voted, partnered with the Y, but the request was eventually disapproved by the board. The proposal might not go to the board this year, but hopefully the vote will be finished by may or early june. Haven't met with YMCA yet, but the Y wants to move out of their old Bremerton facility. A portion of the facility is owned by the city, the state and the government. Has a partnership with UW, where Brandon visited with Trevor Ross to learn more about how it was funded and made possible. Brandon was worried about how much of an influence the Y would have in comparison to OC, but ended up being encouraged by what he saw. The Y will expand the student base and resources offered to students, and will be a great addition to student life.

#### Questions:

Rosie: Would a Y partnership open up more work study positions?

Brandon: UW has it done that way, but if it were here, most likely the Y would be in charge of the hiring process. Supposedly, 85% of employees are students, so the short answer is yes. One advantage of this is Child Watch, which is similar to childcare. This will provide additional support to our current childcare department, which has a staffing issue. Childcare can only have 16 or 17 students working.

Malikah: Brandon could you give details on working in Alaska?

Brandon: Taking off May 7th to get recertified in First Aid and CPR in Alaska. Hoping to work more weekends, a 3 on 4 off or 4 on 3 off. Schedule will fluctuate a little bit, but I will try to maintain good communication. Wherever the Executive Council Meeting lands, Brandon will try to be sure to get that day off.

Malikah: Future executive council meetings. The current schedule has everyone working on Mondays. Unfortunately, Tuesdays, Liam has class on Tuesdays and an internship. (Judie Jose calls, and Katie has to leave for class). If we did Tuesday, it would have to be 8 AM. Other than that, Mondays are best. Every other day, the schedule staggers too much to really be workable. It can be pushed to 8:30 instead. (Brandon further advises meeting be pushes to 8:30)
