Veterans' Memorial Garden: Facilities department donates a special space for a memorial garden, but that wasn't finished before Covid hit. Seeking permission for the 500 dollars from the MVP to be reallocated towards the

memorial garden. Brandon wonders if 500 dollars can be pulled from the next fiscal year's budget. Rosie inquires if reallocations requests are possible at this time. Tatiane says all transactions should have been approved by the 17th, which means it should have been spent by the 10th. Brandon says we'll roll into the reserve in the instance we can't approve the reallocation. Rosie calls for a contingency vote that, if the stipulation can't move forward, we could vote to approve a reallocation right now for future use. Rosie makes the motion, and Liam carries it. 500 dollars will be provided to MVP on July 1st, 2022, if the reallocation does not go through between now and then. Tatiane thanks the student leadership team for their dedication and recognition of the importance of the military population, Brandon provides thanks back for Tatiane's hard word to support the military community.
